In 2021, cyber criminals stole over \$350 million from 13,638 real estate fraud victims.

Do not trust anyone who reaches out to you in an attempt to provide or request wire instructions. This includes phone calls, emails, links, attachments, letters, etc. If you have any questions, call your title company on a phone number that you get directly from their website.
